Retailers Forum

Rural co-operatives provide very valuable retailing services throughout Western Australian covering such things as food, hardware, electrical, farm input supplies and fuel.

As a way of keeping in touch on industry matters that impact on retail businesses a Co-operatives WA Retailers Forum has been established. The Forum will operate using teleconferencing facilities that will help businesses from the Kimberly to the south coast to stay abreast of what is happening in rural retailing without leaving their office. An annual face-to-face workshop is also planned to build on the 'co-operative' retailing business model.

Co-operatives WA will be supporting the Forum through a central secretariat for the 11 retail co-operative retail Members.

The Forum will take networking between Members to a new level, identifying and addressing key issues on a year-round basis.

The Retail Forum model will be rolled out to other groups of Members who have areas of common interest and who would benefit from improved networking.

Co-operative College - UK

Co-operatives WA is working in conjunction with the Co-operative College of Manchester UK, to provide strategy workshops and key training programs to WA co-operatives. Senior staff from the UK College will be in Perth mid-August with a number of Members having already arranged in-house training for directors and senior staff.

The key to a successful workshop is having interested and involved attendees willing to discuss issues and explore solutions. As co-operatives we have a very strong business model. However, like any business co-operatives can't be left to self-manage. They need

strong board direction, committed management and ongoing support from their Membership.

Vale Jim Hughes

It is with great sadness that the Ord River District Co-operative advises the wider Co-operative circle of the sudden and unexpected passing of CEO Jim Hughes.

Jim came to the Ord River Irrigation Area in 1968, only 5 years after commercial farming commenced. Appointed Managing Director in 1983, Jim later became Chief Executive Officer, a position he held until his premature passing on 16 March 2008.

Through his enthusiasm, dynamic personality, business acumen and "can do" attitude, the Co-operative grew from strength to strength through diversification in not only agricultural merchandising, produce exports and grain processing operations but by undertaking the operation of the Wyndham Port facility, commodity storage and handling and importation and distribution of bulk fuel. In fact that

growth led to a recent business restructure and the formation of Cambridge Gulf Limited, a public unlisted company with the new Ordco (Ord River District Co-operative Ltd), carrying on the traditional business of the iconic co-operative known to the region, handling the agricultural merchandising and grain processing operations.

Jim's largest and undoubtedly greatest business achievement was facilitation of the feasibility study and business planning that established the sugar industry and a sugar mill in the Ord Valley with the farming fraternity considering Jim the father of the sugar industry.

Of the many who have contributed to the success of the ORIA Jim Hughes was certainly a major contributor.

Mt Barker co-operative continues to grow



Members of the Mt Barker co-operative will soon enjoy even better shopping facilities with plans to build a rural services building announced in June.

The Co-operative works in partnership with Elders Rural to provide members with a comprehensive rural merchandising service. The decision by the Co-operative's Directors to locate rural services at a more accessible location will improve the logistics of moving goods in and out of the store and make it possible to expand the product range on offer.

"The move will see the new building out of the town centre with easier access for farmers" said Mt Barker Co-op chairman, Chris Enright.

The co-operative has a history of being proactive in providing services to people in the Plantagenet and surrounding shires. Chris Enright and Norm Mills, Co-op general manager were recently pictured in the Albany Advertiser's Great Southern Farmer lift-out symbolically "turning the first sod" for the new facility.

Norm Mills, general manager since 2003 said "The Co-op is focused on providing good customer service and retail facilities for its shareholders and customers and currently provides supermarket, newsagent and hardware facilities as well as fuel for shareholders, all of which will benefit from relocation of rural services."

Co-operatives WA congratulates Mt Barker on their forward planning and commitment serving the needs to their members. Initiatives such as these demonstrate the "co-operative difference" to doing business.
