UWA Centre of Excellence

The Co-operatives WA supported Australian Research Council (ARC) Linkage Grant program is approaching its final phase with the writing up of the academic research findings.

Discussions are also progressing with the UWA on creating an *Australasian Cooperative Enterprise Studies Centre (ACES-Centre)* at the UWA Business School with the Centre to provide various courses of education and training that address the needs of co-operatives and member owned entities.

The work done at UWA by Prof Tim Mazzarol is being recognised at an international level with New Zealand ready to pledge support for a UWA based ACES-Centre as an initiative covering Australasia.

We hope to have a proposal ready to put to the co-operative sector and other member focused entities over coming weeks.

Review of Co-ops Act 2009

On behalf of all Members, Co-operatives WA has made representations to the Department of Commerce on a review of the Act. A Bill to amend the Act is expected to be drafted this year with the aim of streamlining administrative arrangements when a co-operative wants to operate interstate.

We will advise Members individually of any impact changes to the Act will have on their operations. Our representations have been based on minimising changes for existing co-operative through grandfather/preservation clauses along similar lines to what was done when moving from the 1943 Act to the 2009 legislation.

Key Co-operatives Act 2009 reporting deadlines -

Annual Return (Form 10) must be lodged within 28 days of AGM.

Appointment or cessation of Directors and Officers (Form 13) must be lodged within 28 days of change.

Inactive Membership - Time started when?

The day a co-operative was registered under the 2009 Act is the start date of any time related events set out in the Act or the rules of a co-operative. Therefore, to determine when a membership comes up for review due to inactivity, time starts to count from the most recent of:

- date of registration under Co-operatives Act 2009; and
- date the member joined the co-operative.

i.e. for a co-operative that transferred from the 1943 Act to the 2009 Act you disregard any time prior to the date of registration under the 2009 legislation.

The registration date is recorded on the Certificate of Registration issued by the Department of Commerce and mailed out to Co-operatives with a copy of the Registered Rules.

DoT

Hopefully we have resolved difficulties some members have recently experienced with DoT. When registering a motor vehicle DoT applies to co-operatives, the same rules as applied to Incorporated Associations.

In most cases a Co-operative must present its Certificate of Registration when buying/registering a motor vehicle. As such, look after your Certificate and keep it in a safe place, it's more than a wall ornament.

Growers Supporting Growers For Over 50 Years. 1963 -2013

United Crate Co-operative Limited was formed in 1963 by a number of conscientious growers who saw the need to provide a packaging service conducive to the marketing requirements of the State's horticultural industries.

Prior to 1975 the traditional crate varieties were made of wood which was cheap and easily sourced. In 1975 the introduction of the re-usable plastic crate system was developed to supersede its less reliable predecessor.

The Co-operative became one of the first in the State to commercially hire plastic produce bins to complement the existing crate range. Growers who trialed this new addition praised its performance both in the field and its presentation when marketed.

The merits of the plastic crate were heralded as a revolutionary breakthrough on several fronts.

The crates were more durable, more easily transported, and provided better protection of produce, lighter in weight for ease of handling, more hygienic and less taxing on natural resources.

Environmentally, the plastic returnable crate system is sound. All crates and bins broken or damaged through prolonged use can be returned to the manufacturer to be reground to produce new crates. When one considers the amount of disposable packaging that contributes to landfill there can be no comparison.

United Crate has grown from humble beginnings 50 years ago in West Leederville to industry leader, with 5 depots servicing the regional needs of our customers in Carnarvon, Manjimup, Donnybrook and Geraldton.

Many of the original founding members have retired, passing on their knowledge and skills to their children, some of whom have become members in their own right. Also in the last twelve months growers from diverse backgrounds have successfully applied to become a member with the knowledge and benefits of supporting our mutual objectives, thus maintaining the stability and ongoing growth of our Co-operative.
